Having viewed the submitted 'foul and surface water drainage strategy' (ref: ARG/2164-008 5 October 2023) I can advise we have no objections subject to the proposals not changing.

Surface water is proposed to discharge via an indirect connection to the River Tame – we would advise discussing these proposals with the LLFA.

Foul sewage is to discharge to a private existing pumping main which serves the site which discharges via gravity to the public foul sewer.

Please note for the use or reuse of sewer connections either direct or indirect to the public sewerage system the applicant will be required to make a formal application to the Company under Section 106 of the Water Industry Act 1991.
